What, when and where:

Who will be there:

- around 300 participants and 50 high-level speakers;
- prominent European and international decision-makers, law enforcement authorities, multinational companies, small and medium-sized enterprises (SMEs), consumer representatives and other pertinent stakeholders.

Aim of discussions:

- address the pressing challenges of IP enforcement in **the digital age**, with a special focus on SMEs;
- explore strategies how to enhance IP rights enforcement in the EU and internationally ensuring secure world trade flow and safeguarding public and consumer safety;
- spotlight **effective solutions and exemplary cooperation methods** aimed at preserving the international innovative and creative landscape by countering both existing and emerging practices of IP crime.

Strategic timing:

- amidst the policy-making considerations at the **onset of the new mandate of the EU institutions**;
- ahead of the kick-off of the implementation of the **2026-2030 cycle of EMPACT** the European Multidisciplinary Platform Against Criminal Threats;
- take stock of the implementation of the European Commission recommendation on measures to combat counterfeiting and enhance the enforcement of IP rights and recommendation on combating online piracy of sports and other live events;
- analyse the progress stemming from the enactment of the EU AI Act and the Digital Services Act.

The 2025 Summit follows earlier editions in <u>London</u>, United Kingdom (2014), <u>Berlin</u>, Germany (2017), <u>Paris</u>, France (2019), <u>Stockholm (online)</u>, Sweden (2021), and <u>Sofia</u>, Bulgaria (2023).

JOÃO NEGRÃO

Executive Director, EUIPO

João Negrão is the Executive Director of the European Union Intellectual Property Office (EUIPO) since 1 October 2023.

João originally joined the EUIPO as head of the Executive Director's Cabinet in 2010 and between 2011 and 2020 he was Director of the International Cooperation and Legal Affairs Department of the EUIPO. Between 2021 and 2023 he has held the position of President of the EUIPO Boards of Appeal. Before joining the EUIPO, João held different positions in the Portuguese public administration, in the Ministry of Foreign Affairs/General Directorate for EU Affairs, the Presidency of the Council of Ministers and the Ministry of Justice/National Institute of Industrial Property (INPI).

In 2001, he joined the INPI in the international relations cabinet, becoming the Head of Cabinet in 2004. In 2008, he was appointed Director of International Relations and Promotion of Innovation at INPI. João Negrão holds a Master's degree in law and a bachelor's degree in international relations. He also has a number of high level qualifications in Public Administration Management (National Institute of Administration), Leadership Management and High Performance People Skills for Leaders (London Business School) as well as IP-related courses, such as a general course on IP (WIPO Worldwide Academy) and a specialised course on the practice and functioning of the IP system in the USA (USPTO).



DAREN TANG

Director General, World Intellectual Property Organization (WIPO)

Daren Tang has been the Director General of WIPO since 2020.

Under his leadership, WIPO is working to transform the global intellectual property (IP) ecosystem into a powerful catalyst for jobs, investments, business growth, as well as economic and social development for all countries. He is also committed to ensuring WIPO works to harness





the power of IP to provide innovative solutions to our common global challenges.

To make this happen, IP must not just be of interest to specialists and experts but also those innovating and creating at the grassroots, and IP must better serve the needs of women, youth, SMEs and entrepreneurs.

Kyuchyuk holds a Bachelor's degree in Political Science and Management and a Master's degree in Law. He was awarded "MEP of the year" in the category for "Culture and Media" in March 2018 and the honorary title Doctor Honoris Causa in a number of universities.

Kyuchyuk was further awarded in 2023 the Human Rights Award for his tireless work in defence of human rights and dignity, particularly the rights of Uyghurs, as well as the international Giovanni Malagodi Prize, awarded by the Luigi Einaudi Foundation for his dedication in spreading the principles of freedom and responsibility, and the European Liberal Forum "Liberal of the Year" award in 2024.

He has been appointed as Director General of the Hellenic Industrial Property Organisation (OBI) since September 2019.


